Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

The single lethal dose for humans is about 100 ml. Inhalation of high levels of vapour or mists for prolonged periods of time may also result in toxic effects.
